

Final Terms dated 25 September 2017.

*PROHIBITION OF SALES TO EEA RETAIL INVESTORS*

*The Covered Bonds are not intended, from 1 January 2018, to be offered, sold or otherwise made available to (and, with effect from such date, should not be offered, sold or otherwise made available to) any retail investor in the European Economic Area (the "EEA"). 
#### PURPOSE OF FINAL TERMS
